Existing child labor laws and regulations do not apply to children in unpaid or non-contractual work, and gaps in enforcement have left children unprotected from the worst forms of child labor In addition, social programs to combat child labor in Niger are insufficient to adequately address the extent of the problem

In 2014, the Ministry of Employment, Labor and Social Security (MELSS) employed 52 labor inspectors throughout Niger to enforce labor laws, including those related to child labor(4) Given the prevalence of child labor in the country, the number of labor inspectors is inadequate

### **2017 Findings on the Worst Forms of Child Labor: Algeria**

Enforce labor laws, including laws related to child labor, through its General Labor Inspectorate, distribute written notices and issue tickets in response to violations, and refer violations to the Ministry of Justice (6; 21) Supervise the application of laws and regulations related to labor relations, working conditions, and worker safety
